OFFICIAL RULES

In order to be eligible for a scholarship, applicants must work for or be sponsored by an immediate family member who is a member of or an employee of a company that is a current member of the Perishable Foods Council of Northern California and lives/works in the Northern California trade area. (Immediate family member includes son, daughter, brother, sister, mother, father, niece, nephew or grandparent, including in-law thereof). PFC Interns or former Interns may apply for the scholarship. Applicants may receive the scholarship only once. Applicants must complete the application form in its entirety and return it to PFCNC by the entry postmark **deadline December 18, 2023.**

All applicants will be evaluated on the basis of scholastic achievement; Criteria as follows: grade point average (25%), number and length of commitment and quality of leadership responsibilities in community and school activities, awards and honors (30%), quality of the required essay:(45%).

PFCNC will have the sole responsibility for the selection of recipients and its decision will be final. Recipients will be notified by email/mail. All Federal, State and local laws and regulations apply. Recipients shall be responsible for any and all taxes. Recipients will be required to sign and return an Affidavit of Eligibility/Release of Liability. Acceptance of scholarship constitutes permission to use recipient's name and/or likeness for purposes of advertising and promotion

Transfer of the scholarship is not permitted. The award will be paid directly to the registrar at the recipients' school after verification of enrollment and attendance for the spring or fall quarter 2024.
